New Tenant Checklist

**Foresight Village is non-smoking complex.**

**All applicants must have a minimum credit score of 650 to be considered for approval.**

**Application Fee is \$19.00 per adult/cosigner for credit & background check, Unless the applicant elects to provide a Portable Screening Report.**

**All applicants under the age of 21 require a cosigner.**

**All potential tenants aged 18 and up must fill out an application.**

**These are to be provided before final approval of application:**

\_\_\_ Will applicant be using a voucher to pay rent? This information is required to properly process your application.

\_\_\_ Monthly gross income must be at least 2x the rent. (Unless using a voucher, then must be 2x tenant portion)

\_\_\_ Proof of income (2 most recent paystubs or equivalent for potential tenants and co-signers)

\_\_\_ **All applicants must fill out a pet screening profile. This includes applicants without a pet. Please see attached flyer.**

\_\_\_ All pets must be brought into the office before final approval of application.

**These are to be provided before keys will be given to new tenant:**

\_\_\_ Vehicle(s) information including license plate number(s)

\_\_\_ Rental insurance policy to include liability. **Each tenant's name must be listed on policy, or each tenant must have their own policy.**

\_\_\_ Funds for pro-rated rent and full payment of security deposit in the form of cash or check or online at Foresightapartments.com (we do not accept credit cards)

\_\_\_ Pet deposit of \$300 (fully refundable if there is no pet damage)

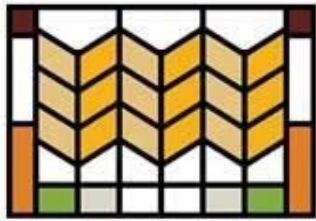
\_\_\_ Proof of Xcel Energy account being transferred from Foresight Village to tenant

## Portable Tenant Screening Report

- 1) THE PROSPECTIVE TENANT HAS THE RIGHT TO PROVIDE TO THE LANDLORD A PORTABLE TENANT SCREENING REPORT, AS DEFINED IN SECTION 38-12-902 (2.5), COLORADO REVISED STATUTES; AND
- 2) IF THE PROSPECTIVE TENANT PROVIDES THE LANDLORD WITH A PORTABLE TENANT SCREENING REPORT, THE LANDLORD IS PROHIBITED FROM:
  - A) CHARGING THE PROSPECTIVE TENANT A RENTAL APPLICATION FEE; OR
  - B) CHARGING THE PROSPECTIVE TENANT A FEE FOR THE LANDLORD TO ACCESS OR USE THE PORTBLE TENANT SCREENING REPORT.

FORESIGHT VILLAGE APARTMENTS RECEIVING A PORTABLE TENANT SCREENING REPORT MAY REQUIRE:

- 1) THAT THE SCREENING REPORT WAS COMPLETED WITHIN THE PREVIOUS THIRTY DAYS
- 2) THAT THE SCREENING REPORT IS MADE DIRECTLY AVAILABLE TO THE LANDLORD BY THE CONSUMER REPORTING AGENCY FOR USE IN THE RENTAL APPLICATION PROCESS OR PROVIDED THROUGH A THIRD-PARTY WEBSITE THAT REGULARLY ENGAGES IN THE BUSINESS OF PROVIDING CONSUMER REPORTS AND COMPLIES WITH ALL STATE AND FEDERAL LAWS PERTAINING TO USE AND DISCLOSURE OF INFORMATION CONTAINED IN A CONSUMER REPORT BY A CONSUMER REPORTING AGENCY;
- 3) THAT THE SCREENING REPORT IS MADE AVAILABLE TO THE LANDLORD AT NO COST TO ACCESS OR USE IN THE RENTAL APPLICATION PROCESS; AND
- 4) A STATEMENT FROM THE PROSPECTIVE TENANT THAT THERE HAS NOT BEEN A MATERIAL CHANGE IN THE INFORMATION IN THE SCREENING REPORT, INCLUDING THE PROSPECTIVE TENANT'S NAME, ADDRESS, BANKRUPTCY STATUS, CRIMINAL HISTORY, OR EVICTION HISTORY, SINCE THE REPORT WAS GENERATED.

### HOW TO MAKE A PROFILE

Note: Applicants without pets must complete the online affidavit, while Pet Owners should gather the following to start:

- Vaccination Records
- Microchip Information
- Photos of Your Pet

1. All applicants should visit:

2. Review the policies and click the 'Start Here' button for No Pets, Household Pets, or Assistance Animals.

3. Enter your contact information, read and accept the Terms of Service, and click 'Create Profile'.

4. *No Pets*: Simply complete the affidavit questions.

*Pet/Animal Owners*: Select the type of animal then click Create a Pet Profile. If you are making an accommodation request for an Assistance Animal, the request box will be preselected.

5. On the next page, click on each section within the profile to enter details, upload photos and attach documents.

6. *For Pets*: Click the green 'Proceed to Payment' button at the top right of the profile, enter payment details and submit. *For Animals*: Click the green 'Submit for Review' button at the top right of the profile.

7. Your Pet Profile will be shared automatically with your housing provider.
